### **RECOMMENDATION:**

Receive and file the attached summary of notices of violation issued and penalty revenue received during the months of January and February 2021.

#### **DISCUSSION:**

Pursuant to Section 40752 of the California Health and Safety Code, the Air Pollution Control Officer shall observe and enforce Part 3 and Part 4 of Division 26 of the Health and Safety Code, all orders, rules, and regulations prescribed by the District Board, all variances and orders prescribed by the District Hearing Board, and all permit conditions imposed pursuant to the District permit program.

In order to keep your Board informed of the enforcement actions taken by the Air Pollution Control Officer, the attached report list a summary of the notices of violation issued and the penalties received during the months indicated. Included in the attached NOV Reports is one violation settlement agreement with a payment plan:

California Asphalt Production, Inc. – Total civil penalty of \$26,400 is being paid in six 1) installments, with the last due in June 2021. Two installments were received: \$4,400 in January and \$4,400 in February.
