DISCUSSION:

District Board Resolution 12-11 specifies that the Board will meet at 1:00 p.m. on the third Thursday of the months of January, March, May, June, August, October, and December. The Board's practice has been to alternate the meeting locations between the Santa Barbara (first half of the year) and Santa Maria (second half of the year) Board of Supervisor's hearing rooms. This schedule also allows us to coordinate closely with that of the Santa Barbara County Association of Governments (SBCAG) Board, who shares many of the same members.

Both of the hearing rooms are equipped to allow remote testimony. District Board meetings are broadcast live on County of Santa Barbara Television (CSBTV channel 20) and on the web (http://sbcounty.granicus.com/MediaPlayer.php?publish_id=35). Attached for your consideration is the proposed 2022 District Board meeting schedule.

Due to the ongoing safety directive measures surrounding COVID-19 and subsequent variants, it is unknown how long the Board meetings will include remote participation in the upcoming hearings in 2022. We will continue to monitor all information coming from the State Legislature, Governor's Office of Emergency Services, and County of Santa Barbara Public Health Department and bring this item to your Board to adjust accordingly.
