### **RECOMMENDATION:**

Adopt and present a Resolution of Appreciation for Vijaya Jammalamadaka upon the occasion of her retirement.

### **DISCUSSION:**

On June 26, 2009, Vijaya Jammalamadaka is retiring from the Air Pollution Control District after 17 years of service as an Air Quality Specialist in the Technology and Environmental Review Division. Prior to her outstanding career with the APCD, Vijaya worked for the Santa Barbara County Planning and Development Department and private consulting firms.

Vijaya has been the APCD go-to person for all things CEQA (California Environmental Quality Act) for air quality plans, rules, and permits. She has reviewed thousands of land development projects in Santa Barbara County for air quality impacts and trained dozens of local land use planners in the finer points of the urban emissions model (URBEMIS). Vijaya authored the APCD Environmental Review Guidelines and the document titled "Scope and Content of Air Quality Sections in Environmental Documents."

Vijaya's dedication to the environment and air quality mission, her willingness to help other professionals, and her infectious laugh will be missed.
