SUBJECT: Control Officer Salary Increase

RECOMMENDATION:

Approve an increase in base salary of the Air Pollution Control Officer by 5 percent over two years with a first year increase of 2.5 percent over the current base salary of \$10,691/month (\$128,300/year) to \$10,959/month (\$131,508/year) to be effective July 2, 2007 and the second year increase of 2.5 percent to be effective June 30, 2008 and adopt a resolution implementing the salary adjustment and amending the APCD Classification and Salary Plan.

DISCUSSION:

On June 21, 2007, the Board completed the annual performance evaluation of the Control Officer, Terry Dressler, pursuant to Section 6 of his employment agreement and approved the recommendation of the Executive Committee to increase the Control Officer's base salary by 5 percent over two years. The first year 2.5 percent increase will be effective on July 2, 2007 and the second year 2.5 percent increase will be effective June 30, 2008.

Pursuant to Board Resolution No. 06-10, the Board directed the Control Officer to return at the August 16, 2007 Board hearing with a resolution enacting the salary adjustment, the first half of the adjustment to be effective the beginning of the fiscal year, which is July 2, 2007.

RECITALS

- 1) Whereas on June 21, 2007, the Board completed its annual job performance review of the Control Officer Terry Dressler; and
- 2) Whereas the Board has determined that it is appropriate to increase the salary of Mr. Dressler by the amount of 5 percent over two years.

NOW, THEREFORE, IT IS HEREBY RESOLVED THAT:

- 1) This Board has held a hearing and accepted public comments on this matter; and
- 2) The Control Officer, Terry Dressler, is hereby given an increase in base salary of 5 percent over two years; and
- 3) The first year increase of 2.5 percent over the current base salary of \$10,691/month (\$128,300/year) to a base salary of \$10,959/month (\$131,508/year) shall be effective July 2, 2007; and
- 4) The second year increase of 2.5 percent shall be effective June 30, 2008.
- 5) Pursuant to Section 7 of the Control Officer's employment agreement and Section 2 of Board Resolution No. 06-10, this salary increase is in addition to any cost of living adjustments given to District management staff.
- 6) Board Resolution No. 97-05, adopted on June 19, 1997, and most recently amended on June 21, 2007, is hereby amended by amending Section 4 (Job Class Table) as presented in Attachment 1.
- 7) The Board authorizes the Control Officer to transmit this resolution to the County Auditor and to do any other acts necessary and proper to implement the salary increase.
