Earth Day 2000 celebrations in April set the stage this year for Clean Air Month, the month of May. More than twenty-five APCD staff helped out with Earth Day and other events around the county in April, demonstrating cleaner electric and gas-electric car technologies, discussing environmental careers, encouraging kids (and adults) to make clean-air pledges, and bringing electric car kits (made possible with help from California Air Resources Board) to county classrooms. Clean Air Month at the Museum

Clean Air Month is celebrated locally by APCD and the American Lung Association of Santa Barbara and Ventura Counties (ALA). This year, APCD and ALA sponsored a special exhibit at the Santa Maria Discovery Museum. The exhibit features Air World, an interactive computer display with air pollution facts narrated by celebrities. Air World was originally developed by the Ventura County air district with a grant from the federal **Environmental Protection** Agency. APCD recently customized it with information on Santa Barbara County, and is currently developing a stand-alone kiosk for Air World.

The Clean Air Month exhibit also features slides on air pollution and lung health, and a display of preserved pigs lungs. Kids can breathe into a tube to inflate the lungs and see how they work. During Earth Week in April at the museum, the Santa Maria

Smog Season Is Here

Smog season for our county started this year on April 12, when the Carpinteria and Nojoqui Summit monitoring stations recorded levels of smog (ozone) higher than the state standard. On May 1st, the Las Flores Canyon station also recorded an exceedance of the state standard. So far our monitoring stations have not recorded any exceedances of the federal one-hour ozone standard this year. Our county is currently designated by the federal Environmental Protection Agency as a "serious" ozone nonattainment area, and is seeking redesignation as an attainment area, based on smog levels during 1997-1999. Smog levels in our county have been going down, thanks to efforts by businesses and individuals to reduce emissions, and thanks to cleaner cars. Weather patterns over the past three years have also helped keep smog levels down. But it was close. With just one more federal exceedance at one of our monitoring stations during the 1997-1999 period, we could be facing redesignation as a "severe" nonattainment area instead of looking at attainment. A lot depends on what happens during this year's smog season. Stay tuned!

APCD Board Roundup

Following are the highlights of the February, March, and April Board meetings.

February

- Executed grant agreements for low-emission main boat engines and generator engines (estimated to cut 7.8 tons of smog-forming emissions over ten years).
- ✓ Adopted a resolution recognizing attainment of the federal ozone standard during the years 1997 through 1999. Recognized APCD staff for the achievement.

March

- ✓ Executed a grant agreement for the purchase of a low-emission boat engine (estimated to cut 1.6 tons of smog-forming emissions over ten years).
- ✓ Received and filed the 1999 annual report on APCD's Air Toxic "Hot Spots" Program, and approved the proposed program budget for FY 2000-2001.

April

- ✓ Executed a grant agreement with the Channel Islands National Marine Sanctuary for purchase of two lowemissions boat engines (estimated to cut smogforming emissions by 12.3 tons over ten years).
- ✓ Executed a grant agreement with Santa Barbara Metropolitan Transit District to provide \$10,000 to initiate and evaluate the viability of a new electric bus route.

Preventing Pollution

Pollution prevention experts from all over the country gathered in Boston recently to discuss Expanding Pollution Prevention Horizons, the focus of the National Pollution Prevention Roundtable's annual spring conference.

APCD's Frances Gilliland moderated a conference session on local government success stories. The session showcased projects in northern California, Denver, and the City of Gastonia in North Carolina that model innovative, voluntary strategies by businesses and communities to prevent pollution. One of many conference highlights was a speech by Judith Kurland, Regional Director of the U.S. Department of Health and Human Services, Region 1. Kurland pointed out that children are particularly vulnerable to pollution in our environment, and stressed the need to see pollution prevention as a public health issue.

Representatives from the State and Territorial Air Pollution Program Administrators (STAPPA) and the Association

- Educate yourself and your employees about air pollution and how to prevent it. Check out our web page at www.sbcapcd.org.
- Become involved in your community's land use decisions. Speak out in favor of walking-friendly, biking-friendly development. If you are an employer, encourage your employees to leave their cars at home. Contact Traffic Solutions at 963-SAVE or visit www.sbcag.org/ts.htm for ideas.
- Take the time to think about how your business operates. Can manufacturing processes be modified or eliminated to reduce the amount of pollution (waste) generated?
- Think before you buy. Do you really need it? Is it made from recycled materials? Can it be re-used or recycled? Set up a recycling program in your office or business. Call the County of Santa Barbara's Solid Waste Division at 882-3600 and look at www.lessismore.org.
- Do not pour grease or chemicals of any sort into the sewer or storm drain. Photographic fixer and stabilizer, used motor oil, paint thinner, and other chemicals require special disposal and can be taken to the household and small business hazardous waste collection center at UCSB. Call the Community Environmental Council at 963-0583 for more information, or visit www.grc.org. Lompoc residents and businesses can call the City of Lompoc Hazardous Waste Collection Facility at 736-1261 ext. 524.

of Local Air Pollution Control Officers (ALAPCO) offered insights on pollution prevention in air programs. They discussed work focusing on emissions from power plants, urban air toxics, mobile sources, federal operating permits, and climate change.

Other sessions at the conference explored how the way our communities grow affects air quality, solid waste, traffic congestion, and other factors that impact our quality of life. Communities across the country shared ideas for reducing these impacts, making more efficient use of land resources, and preserving natural resources.
